- 1) **CALL TO ORDER:** The meeting was called to order by President Nightengale at 7:00 p.m.
- 2) <u>ADOPTION OF AGENDA:</u> Superintendent David Younger presented to the Board of Education to add a student presentation of the FFA officers to the Reports (6.a). The motion was made by Clay Scott to adopt the agenda with the addition to the reports for Clay Scott with a seconded Jamie Kratzer. The motion passed 7-0.

- a) Student Presentation
 - UHS FFA Officers presented to the Board of Education a proposal to attend the National FFA Convention from October 26th-30th in Indianapolis, Indiana and the Board of Education covered the cost of transportation. 8 students would be attending and 2 sponsors the convention. Ron Smith made a motion to approve the UHS FFA Field Trip proposal as presented with a seconded from Mike Meyer. The motion passed 7-0.
- b) Principal Reports
 - UHS Principal Mark Paul presented the Board of Education two donations: Friends of Buffalo Dunes for \$1,0000 for the golf team and \$11,000 donation from the Big Orange Boosters to the UHS Athletics. Jamie Kratzer motioned to accept the donations from the two organizations with a seconded from Diana Nunez. The motion passed 7-0.
- c) Director of Student Learning
 - i) Kevin Warner updated the Board of Education on current professional development going on in the district with Adaptive Schools with Dr. Kelly Gillispie, ELA curriculum mapping with Suzy Meyers, and the work that KESA DLT team has completed with Dr. Amber Miller.
- d) Superintendent's Report
 - i) Superintendent David Younger provided the Board of Education with the number of Home Economics Survey, 1,300 surveys have been turned in at this time. Superintendent David Younger reviewed with the Board of Education that this survey will be used for At-Risk Funding. The district will be having a raffle for the families that completed the Home Economics Survey for each of the school buildings.
 - ii) Superintendent David Younger provided an update to the Board of Education at this time the overall district student enrollment at this time is down 60 students.

7) **<u>NEW BUSINESS:</u>**

a) Field House

 Nick Nemichek from GMCN Architect Firm presented to the Board of Education rendering drawings, blueprints and possible budget for a possible Field House at the football field and track. Ron Smith made a motion to proceed to finalize and continue the development of construction designs for the field house. The second was made by Diana Nunez. The motion was passed 7-0.

8) OLD BUSINESS:

- a) COVID Update
 - i) Superintendent David Younger and Head School Nurse Ruby Romero updated the Board of Education about COVID in the District. Superintendent David Younger shared three emails from parents about supporting wearing masks at school, reviewed the updated guidance for COVID-19 Prevention in K-12 Schools, and newsletter for school recommendations from CDC and KDHE, reviewed the USD 214 COVID protocols. Superintendent David Younger also updated the Board of Education that students even wearing a mask at school would still be quarantined by the County Health Department.
 - ii) Superintendent David Younger presented to the Board of Education an addition to test students for COVID through a grant from KSDE to help lower the number of students and shorten the length of quarantined students. The parents would opt-in for the rapid COVID testing. The grant would pay for rapid COVID tests of students, a nurse and administrative assistant to administrator and manage the COVID rapid-testing. Dianna Nunez motion to approve a opt-in COVID rapid testing program for in-school close contact exposure with a seconded with Jamie Kratzer. Motion passed with a 6-1 vote with the dissenting vote from President Margaret Nightengale.
